


**DEPARTMENT OF REVENUE'S MOTION
FOR EXTENSION OF TIME TO FILE ANSWER**

The Illinois Department of Revenue, (the "Department") by and through its attorney, George Foster, Special Assistant Attorney General, respectfully requests this Tribunal to enter an order extending the time for filing the Department's Answer to Taxpayer's Petition, and in support of its Motion states as follows:

1. Per order entered August 26, 2015, the Department's Answer is due September 16, 2015.
