**DEPARTMENT’S MOTION TO EXTEND TIME TO ANSWER**

Now comes the State of Illinois, Department of Revenue (“Department”), by its duly authorized representative, Special Assistant Attorney General, Susan Budzileni, and pursuant to 86 Ill. Adm. Code § 5000.315, hereby moves this Honorable Tribunal to enter an order extending the Department’s time to file an answer in this matter currently pending before this Tribunal. In support of its motion, the Department states as follows:

1. On April 13, 2016, Petitioner filed a petition with the Illinois Independent Tax Tribunal (“Tribunal”).
2. On April 18, 2016, the Tribunal accepted Petitioner’s petition and ordered the Department’s answer to be filed on or before May 31, 2016.
3. On May 23, 2016, Department’s counsel contacted Petitioner’s counsel and advised Petitioner’s counsel that the protest matter may be resolved through the submission of documents.
4. On May 26, 2016, the parties discussed the protest matter and Petitioner’s counsel is prepared to submit revised documents/schedules or other information to Department’s counsel

for the Department's Business Processing Unit to review and determine if said submission(s) will resolve the issues in this matter.

5. The Parties anticipate that this matter can be amicably resolved without the necessity of the Department filing an answer.

6. The Parties discussed the Department's request to extend its time to answer and Petitioner's counsel is not opposed to the Department's request.

7. There will be no prejudice to either party if this motion is granted.

8. This motion is not meant for the purpose of delay or harassment.

WHEREFORE, the Department respectfully requests that this Tribunal enter an order granting it additional to file its answer and such other and further relief as it deems just and proper.
