DEPARTMENT’S UNOPPOSED MOTION FOR EXTENSION OF TIME TO FILE ANSWER

The Illinois Department of Revenue, (the “Department”) by and through its attorney, Michael Coveny, Special Assistant Attorney General, respectfully requests that this Court enter an order extending the date to answer Taxpayer’s Petition filed in this Tribunal and in support states as follows:

- 1) Taxpayer filed its Petition in this Tribunal on January 21, 2014.
- 2) Per order entered January 21, 2014, the Department’s Answer was due February 20, 2014.
- 3) On February 21, 2014, this Tribunal entered an order granting the Department’s First Motion to Extend the Time for Filing its Answer to March 6, 2014.
- 4) Although the Department’s attorney has completed the answer, he was not able to obtain the necessary signature verification by March 6th due to a family medical emergency requiring him to spend time at the hospital and miss work.
